NEW BUSINESS

Consideration and Approval of Budget Amendment 2017/2018-003 for the sidewalk in front of the Police Department.

Sal Gallelli, 1104 N Tangerine Ave, asked if Chief Thomas got bids for the work to be done on the sidewalk. **Chief Thomas** replied that according to the Town's purchasing policy under \$5,000.00 you don't have to get bids.

<u>Councilor Mabry</u> seconded by, <u>Mayor Pro-Tem David Nebel</u> moved to approve Budget Amendment 2017/2018-003 for the sidewalk in front of the Police Department. Motion carried 4-0 with a roll call vote.

Discussion: Annexation of property (Councilor Scott)

Councilor Scott said that there is a Groveland sign at Dewey Robbins.

Councilor Mabry said that he had a resident ask if they still lived in Howey.

Mayor Sears said that Groveland has gone as far as they can go.

Councilor Scott said that he has a handout that was passed to all Town Council Members. This is where he would like to see the Town expand too.

Mayor Sears read aloud the handout. The Town's possible expansion west on Number Two Road to Blue Sink; North on State Road 19 to Hickory Point; Buck Hill Road to North Palm Ave; North Palm Ave to Revels Road; State Road 19 south to East Dewey Robbins. Then west on County Road 48 to Yalaha cut off Road. He asked what the benefit is of annexing all that property was. **Councilor Scott** said that in the future we could have more ad valorem taxes.

Mayor Sears said that to annex property there is a cost involved and that takes time.

Chief Thomas said that all the other roads Councilor Scott talked about would be annexing through the County. The only one that would have to go through the State is the road right of way on State Road 19. In 2015 he proposed taking over the Howey Bridge and getting paid as they run all the calls on the bridge anyways. **Mayor Sears** asked how the Town gets paid. **Chief Thomas** replied from the citation.

Chief Thomas said that they have to wait for Florida Highway Patrol to arrive. Which is anywhere from thirty minutes to over two hours. If they had jurisdiction they could clear the bridge in thirty minutes.

Councilor Mabry said that he understands wanting the jurisdiction since the police officers are already working the incident.

Mayor Sears said that he would like to get a plan together and asked how the Town Council would like to proceed.

PUBLIC COMMENTS

Sal Gallelli, 1104 N Tangerine Ave, said that he agrees with Mayor Pro-Tem David Nebel regarding finding out the cost of annexing property. He wanted to know if writing a citation was a negative or positive thing for the Police Department. He then said that he was confused on how many homes were actually being built in Venezia since Councilor Scott said 140 and our Town Clerk said 80. **Mayor Sears** said that there are probably a few different numbers some are under construction, occupied, or permits have only been pulled. **Chief Thomas** said that his officers go to court regarding a written citation. He then said that the benefit may not always be in favor of the Town as the State and Judge impose the fees. He said that he does his best to balance the check book.

Marie Gallelli, 1104 N Tangerine Ave, asked if a resident had to use the Town Building Official. Mayor Sears replied no that you can use any other inspector. She then asked if his contract was up. Mayor Sears said that in September 2017 it came before the Town Council and the Town Council chose to continue his contract. She then asked what the status was regarding the Special Magistrate. Mayor Sears said that it is on his to do list.

Cynthia Smith, 308 N Palm Ave, wanted Mayor Sears to bring the residents up to date regarding the Library landscape. Mayor Sears said he met with the party who is interested in the Florida Native Plants and discussed that he would like to bring in a Landscape Architect to come up with a professional design for the front of the Library. He would then meet with the Parks and Recreation Advisory Board to discuss what the Landscape Architect has proposed and move forward form there. Mrs. Smith commended Mayor Sears for trying to bring the two parties together. She said that the ladies on the Parks and Recreation Advisory Board do a spectacular job. That she wished their opinion was respected more and that Town needs to protect our volunteers.
