Dear Ms. Burke;

WCA is pleased to be the solid waste and recycling service provider for the Town of Howey and I am amazed that a year has already gone by. I hope that WCA is not only meeting, but exceeding the expectations for the Residents, the Town Council and the Staff of Howey.

In section 10.2 (a) of our contract, adjustment to rates, the Contractor may petition the Town council annually for an annual CPI adjustment which shall not be unreasonably denied. The CPI for 2018, as reflected in the attached table, is 2.7%.

The calculation for the residential collection rate increase for FY 2018/2019 is 2.7% times the current residential rate which equates to an increase of \$.42 per home per month for a new rate of \$16.34. Commercial rates will also be adjusted to reflect the 2.7% increase. (See attached pricing matrix). Rate adjustments will go into effect October  $1^{st}$ , 2018.
